- 8. English responses come naturally, although they may be imperfect. Student has a good vocabulary and understands almost everything. Can respond intelligently, but needs practice.
- 9. Student possesses near fluency. Sentence structures are almost perfect. Can understand difficult

problem communicating when he/she arrives in the United States.  10. Absolute proficiency in English. Student is able to understand and converse in English using abstract terms and complicated sentence structures.
