

Foreign Student Exchange Agency Assurance Form

The _____ (agency) will comply with the following requirements for participation in foreign exchange student placements for the **2026-27** school year.

Initial each item below:

<input type="checkbox"/>	The agency has complied with all applicable policies of the Jordan District Board of Education regarding foreign students (Policies AS60 and AS66) and all registration processes and procedures as outlined by Planning & Enrollment. Ongoing placement of students in Jordan School District is conditional on agency compliance with District policy.
<input type="checkbox"/>	A household study, including a background check of ALL adult residents, has been made of each household where an exchange student is to reside, and that the study was of sufficient scope to provide reasonable assurance that the exchange student will receive proper care and supervision in a safe environment.
<input type="checkbox"/>	The host parents have received training appropriate to their positions, including information about enhanced criminal penalties, under Utah Code §76-5-406(2)(j), for persons who are in a position of special trust.
<input type="checkbox"/>	A representative of the exchange student agency shall visit each student's place of residence at least once each month during the student's stay in Utah.
<input type="checkbox"/>	The agency will cooperate with school and other public authorities to ensure that no exchange student becomes an unreasonable burden upon the public schools or other public agencies. This includes providing tutoring or other assistance as needed, as foreign exchange students do not qualify for Special Education or Section 504 services.
<input type="checkbox"/>	Each exchange student will be given (in their native language) names and telephone numbers of agency representatives and District personnel (available from Planning & Enrollment) and others who could be called at any time if a serious problem occurs.
<input type="checkbox"/>	Alternative placements are readily available so that no student is required to remain in a household, if conditions appear to exist which unreasonably endanger the student's welfare.
<input type="checkbox"/>	The agency understands that if for any reason, a student moves to a new host family, the agency will receive approval from Planning and Enrollment prior to undertaking the move and assist in coordinating any changes in school registration.
<input type="checkbox"/>	The agency verifies that the host family submitted to Planning & Enrollment is not a "Welcome Family."
<input type="checkbox"/>	The agency understands and has communicated to the student that, if the student is enrolling in 12th grade and intends to graduate from a District school, an official transcript of credits earned in the home country is required . The student may be liable for the time and expense of make-up credits to meet all Utah graduation requirements.
<input type="checkbox"/>	The agency and student understand that in the event that tuition reimbursement from the Utah State Board of Education is unavailable, the District may (at its discretion) revoke the offer of enrollment or student will be required to either a) personally cover the cost of out-of-state tuition, or b) apply for and be granted a tuition waiver from the Jordan School District (subject to availability).
